## **Annual SCFCNA Conference: Spirituality and Resiliency; Fostering Resiliency in Others and Ourselves**

On **Saturday, August 10, 2013**, the SCFCNA's Annual Conference will be held at Northeast Presbyterian Church, 601 Polo Road in Columbia.

The conference is open to all interested in faith community nursing and health ministry workers, to include nurses, chaplains, pastors, health promoters, and lay ministers.

The featured speaker is **Dr. Alexis Smith**, an ordained chaplain and serves at Wesley Long Hospital in Cone Health Systems in Greensboro, NC. She is the author of several publications and completed a research study on "Finding Meaning and Hope in Situations of Suffering and Loss".

Dr. Smith will present three sessions on the topic of resiliency and spirituality. Session 1 will explain the concepts of resiliency and spirituality in facing death and dying. Session 2 will compare and contrast factors that support resilience with those that work against it and apply this knowledge to foster development of the supportive factors in self. In addition, Session 3 will encourage the telling and connecting of personal stories in healing ways to facilitate the development of resiliency. Each session will include exercises using assessment tools to support the concepts presented.

A pre-conference session will be held for those participants interested in beginning a ministry and will give tips on how to start a successful Faith Community Nursing Ministry.
