# **President's Report on 2023 Activities**

In 2023 the SCFCNA held quarterly meetings at First Baptist Church in Irmo where we provided CE credit for the educational offering. These meetings were held in person and virtually to allow for the attendance of more members.

- In January, we had a presentation on Grief Share provided by Wendy Bobadilla and Renatta Loquist. This presentation gave an overview of the program and tips on how to use it in the members' congregations.
- In April, the presentation was provided by Marisette Hasan and focused on End of Life
  Care Decisions and Planning Strategies. This presentation provided objectives, strategies
  and steps for Faith and Community engagement in advanced care planning.
- In July, Jenais Y. Means, presented information on, "Creating Pathways for Spiritual Growth", and included exercises and group activities. She generated suggestions from the group about how we can incorporate new, inclusive, and supportive practices for our organization.
- In August, we had our annual conference which was set up as a retreat entitled "Come
  to the Well" and focused on renewal, reconnecting, refreshment, and revival. With
  emphasis on self-care and resiliency.
- In October, we had a presentation regarding the activities and resources available through the Big Red Barn which provides care and support for military personnel and first responders.

The SCFCNA will be offering a foundations course in 2024 to provide nurses with training in the scope and practice of Faith Community Nursing. More information is provided below.

The SCFCNA has also participated as a vendor for the South Carolina Student Nurses Convention and the South Carolina Nurses Convention.

SCFCNA nominated one of its members for the Palmetto Gold Award and supported the Palmetto Gold Program with an advertisement in the annual publication.

The SCFCNA has provided quarterly articles for the SCNA newsletter which included the activities of the members in their faith communities. As part of the underpinnings of the organization, meetings of the executive board, board of directors and education team were conducted throughout the year. The membership has increased to 56 faith community nurses in 2023, and we are interested in discovering other nurses who have ministries in their faith communities as well as health ministry leaders and pastors.
